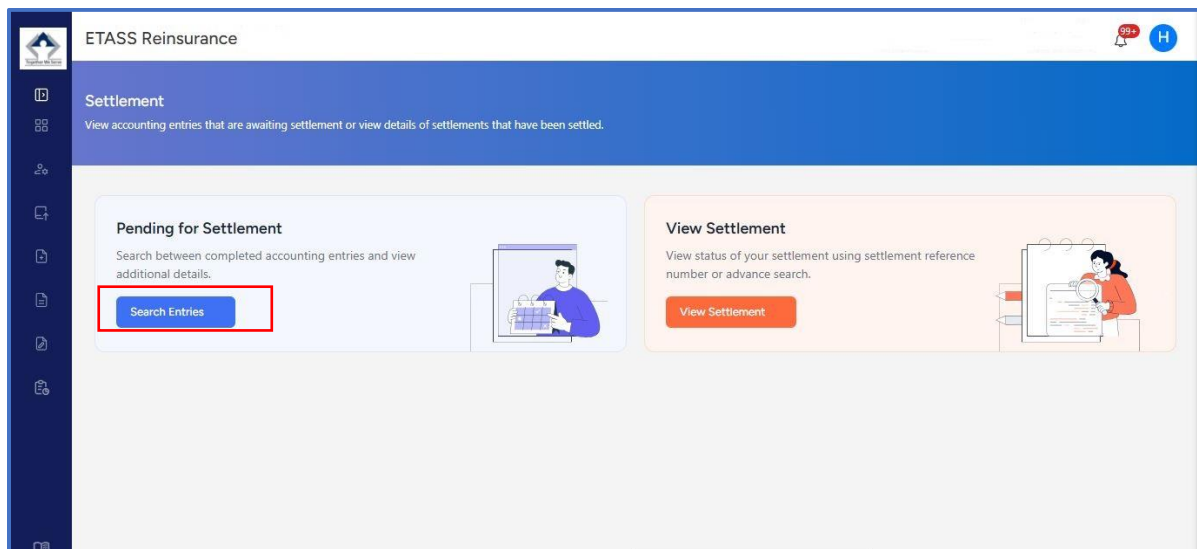
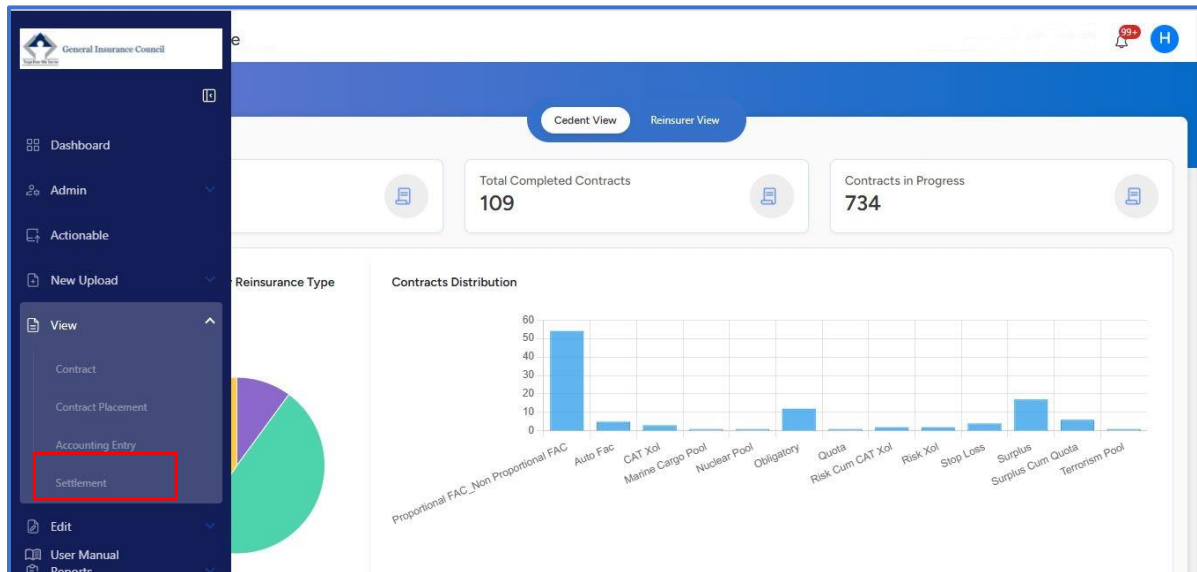
1. Introduction to Settlement

Settlement is the process of finalizing financial transactions between involved parties, such as cedant, reinsurers, and brokers, by ensuring that all approved accounting entries (AEs) are accurately paid and recorded. It includes stages such as uploading settlement details, verification, approval or rejection, and final confirmation, thereby enabling smooth financial closure of transactions.

2. Pending for Settlement – Search & Download

Step 1: Access Pending Settlement

- Log in with Broker credentials.
- Navigate to **View** → **Settlement** → **Pending for Settlement**



Step 2: Search Functionality

- Open the Advanced Search section.
- Apply filters to view approved Accounting Entries (AE) pending for settlement.
- In Company Name / Beneficiary Name:
 - Select values from a multi-select dropdown
 - Use the “All” option to view all records
 - Use the search field with type-ahead suggestions for quick selection
- The system displays the payable or receivable party as:
 - Cedant/Reinsurer → For broker placement
- An AE is displayed in the ‘Pending for Settlement’ list only after settlement has been initiated by either the cedant or the reinsurer.
- The system excludes:
 - AE numbers where settlement is already initiated by the broker.

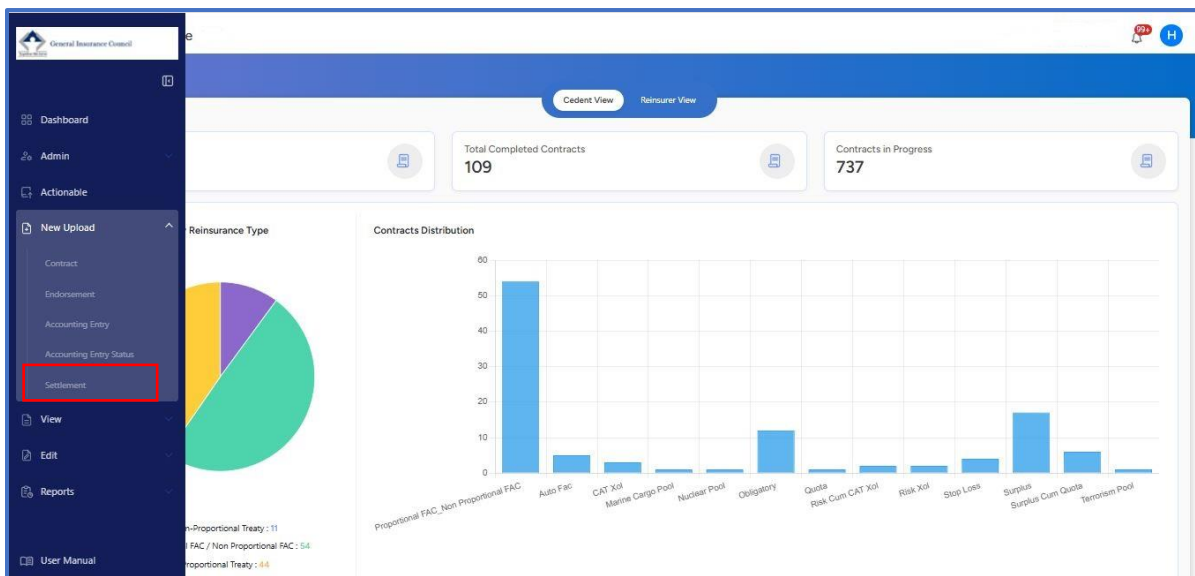

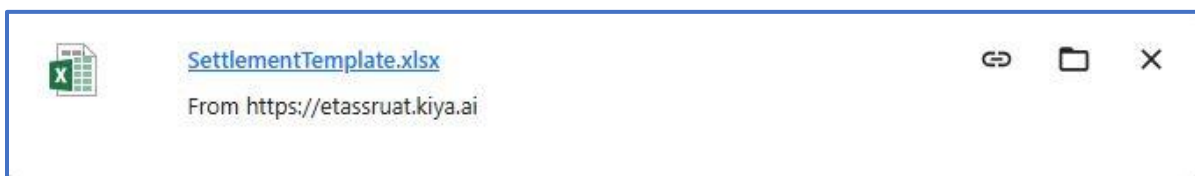
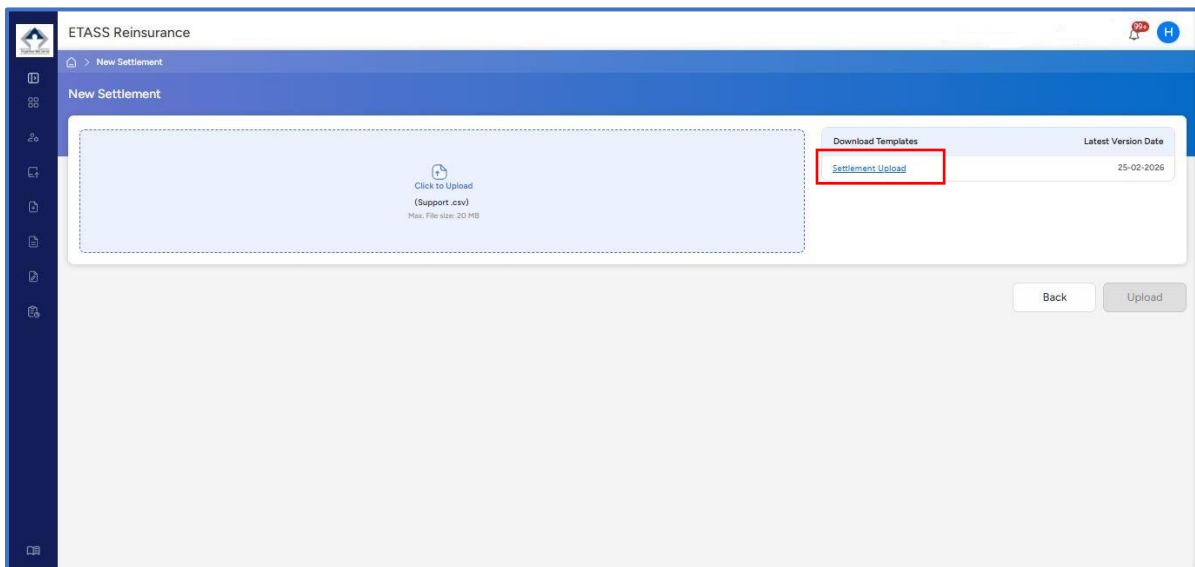
3. Settlement Upload Functionality

Step 1: Upload Settlement

- Go to **Menu** → **New** → **Settlement**



- Click on **Settlement Template** under **Download Template** to download the settlement template.

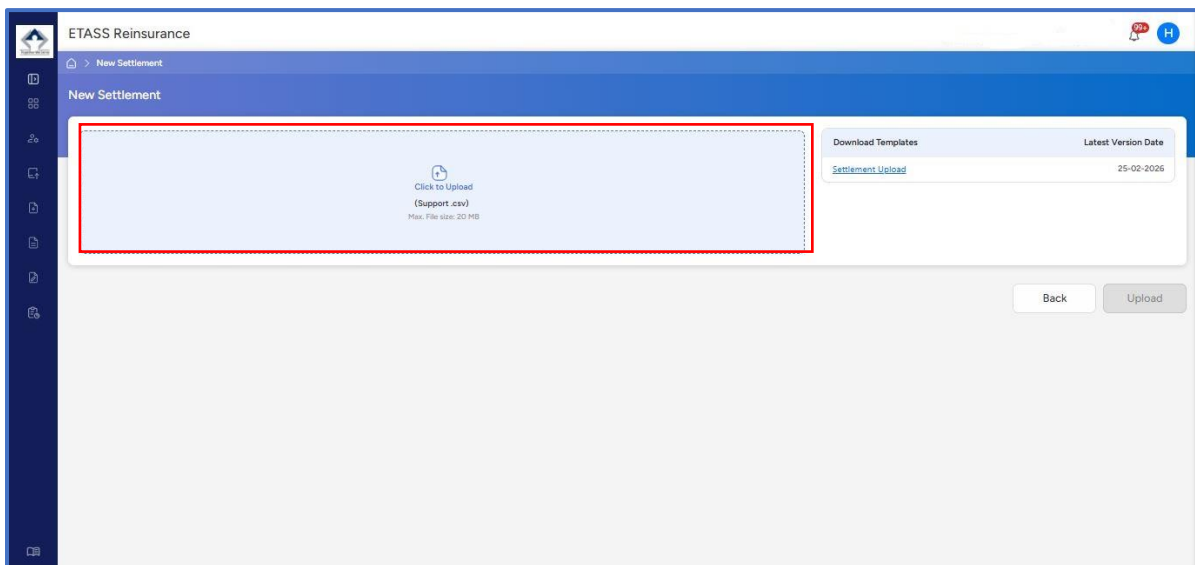


- Once the template is downloaded user needs to fill the below details in the settlement template :

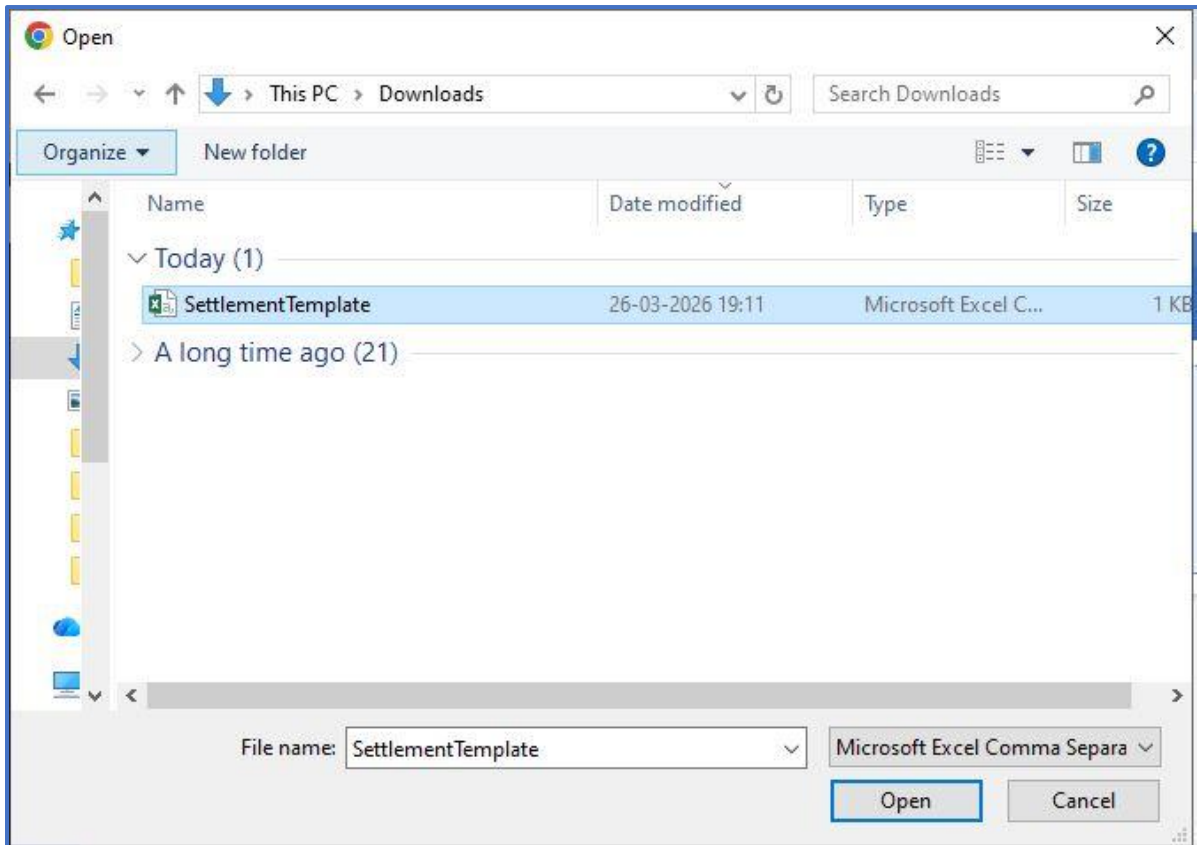
Column Name	Description
AE Number	Mandatory field. Enter the AE Number for which the settlement needs to be uploaded.

Cedant Name	Enter the Cedant name for the selected AE. The portal will not validate this field; it is for user reference only.
Broker Name	Enter the Broker name for the selected AE. The portal will not validate this field; it is for user reference only.
Reinsurer Name	Enter the Reinsurer name for the selected AE. The portal will not validate this field; it is for user reference only.
Amount	Enter the amount for the selected AE. The portal will not validate this field; it is for user reference only.
Booking Currency	Enter the booking currency for the selected AE. All selected AE numbers must have the same booking currency. Multiple booking currencies cannot be uploaded in a single file.
Credit/Debit Note Reference Number	Mandatory field. Enter the Credit/Debit Note Reference Number.
Credit/Debit Note Date	Mandatory field. Enter the Credit/Debit Note Date in DD-MM-YYYY format.

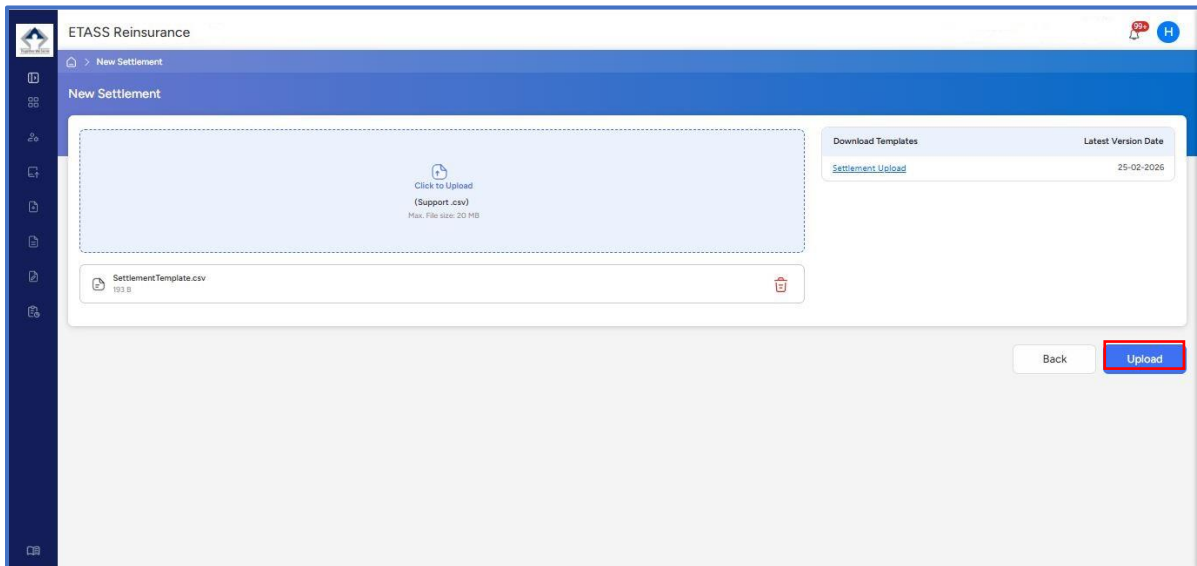
- Before saving the file please ensure the following:
 - Same Reinsurer & Cedant across the file
 - Same Booking Currency for all records
 - No partial processing is allowed
 - The selected AE numbers should have same booking currency. Multi booking currency cannot be uploaded in one file.
 - File to be saved in CSV format.
- Entire file will fail if any record fails validation. After completing the file, click on **“Click to Upload”**.



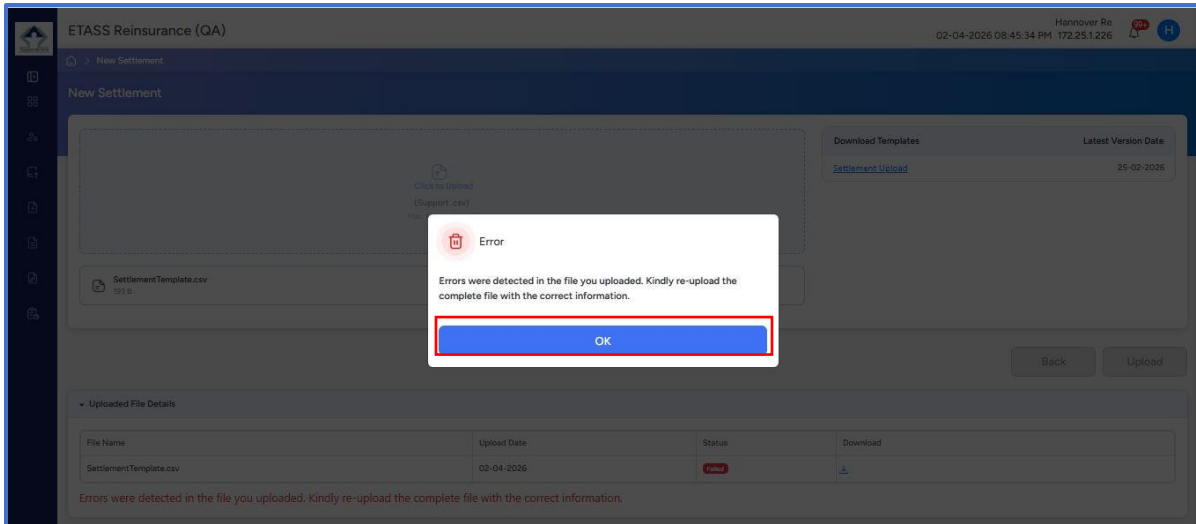
- Select the file from your browser.



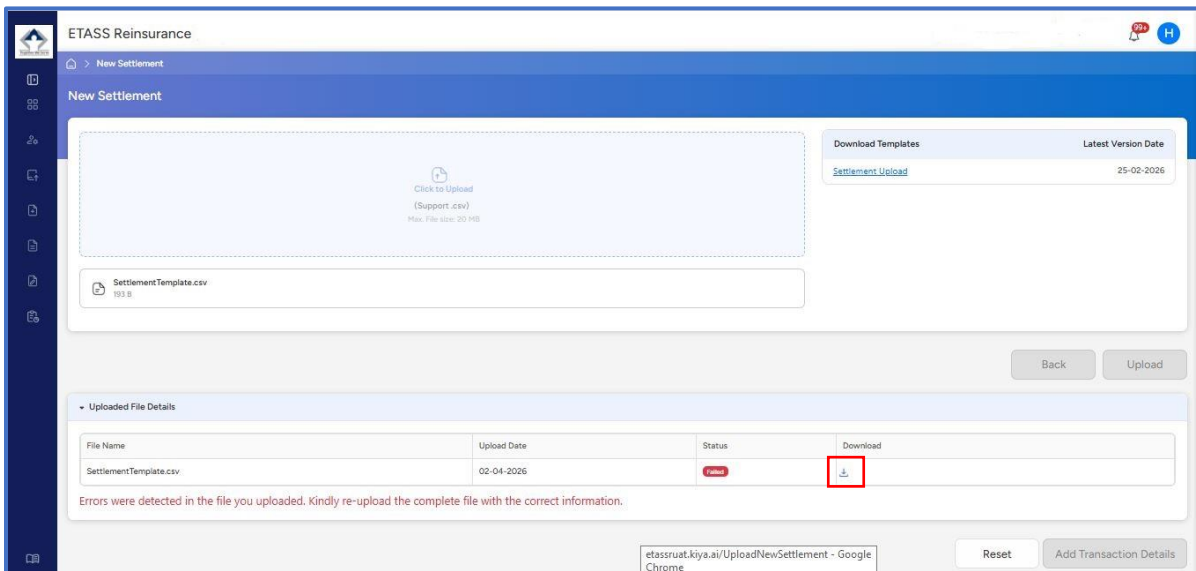
- Once a file is attached, the **Upload** option is enabled.
- Click on the **Upload** button to upload the file.



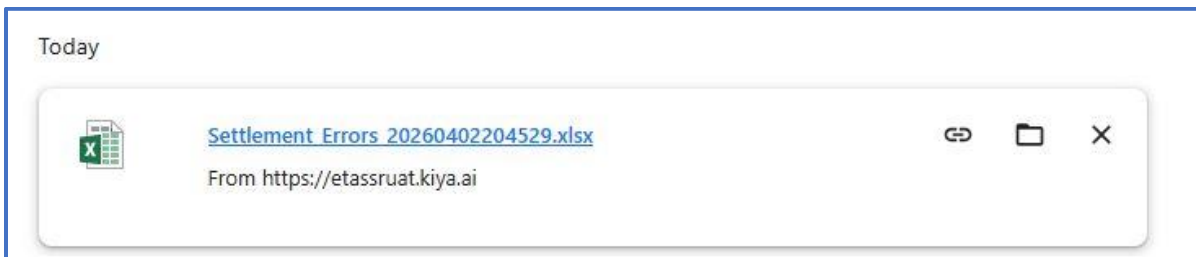
- If validation fails, system shows the message:
 - “Errors were detected in the file you uploaded. Kindly re-upload the complete file with the correct information.”



- On clicking the “OK” button, the grid will be displayed showing the **File Status** and a **Download** option (available only if the file has failed).

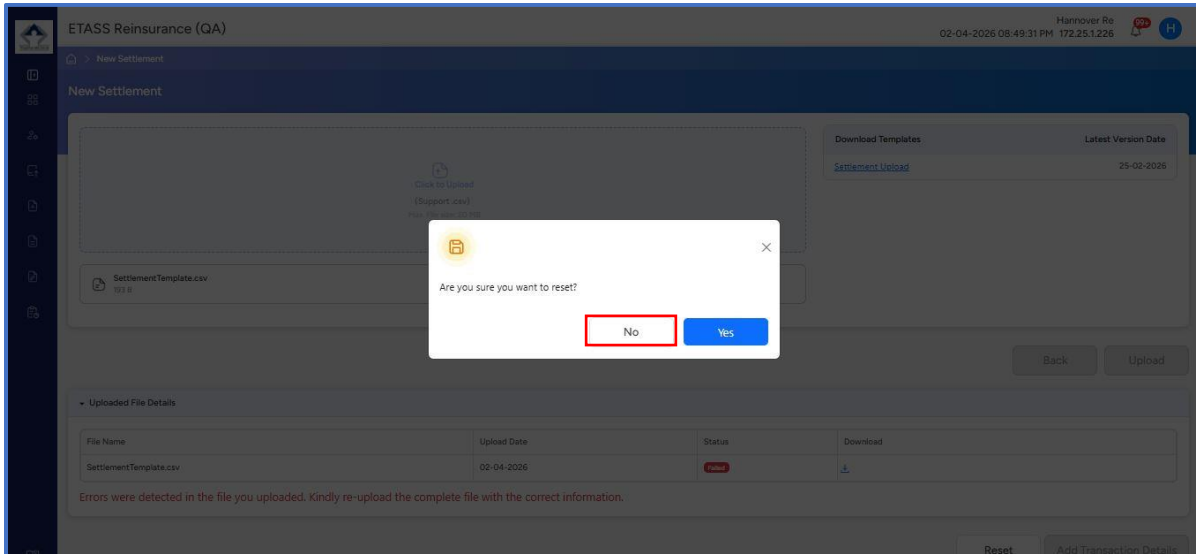


- On clicking the **Download** option, the failed uploaded records will be downloaded along with detailed error reasons in the **Remark** column.

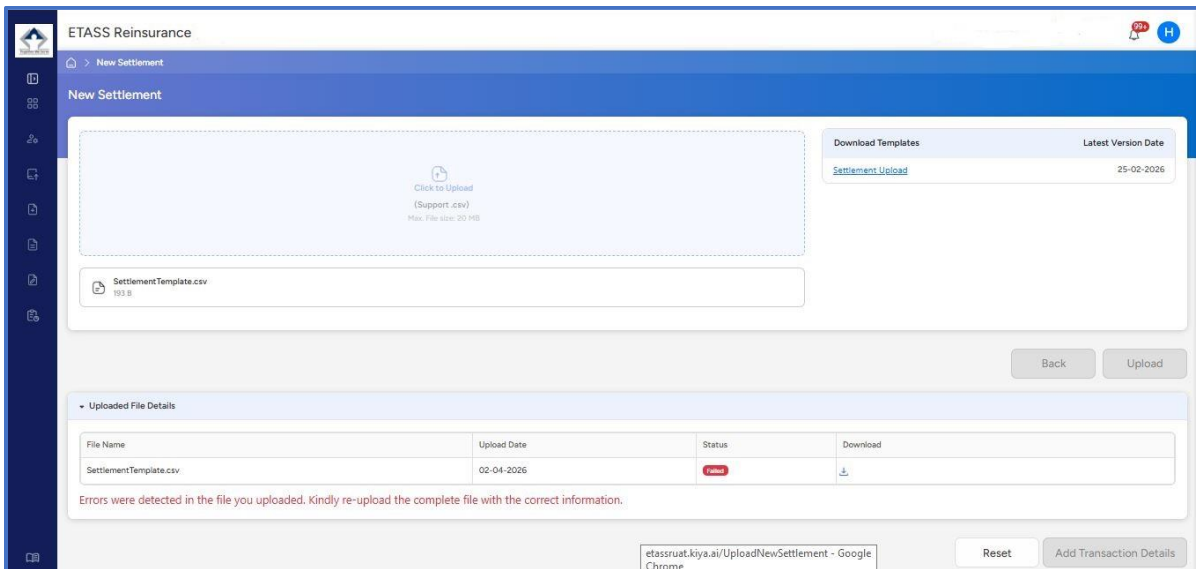


- After reviewing the error reasons, make the necessary corrections and re-upload the file.

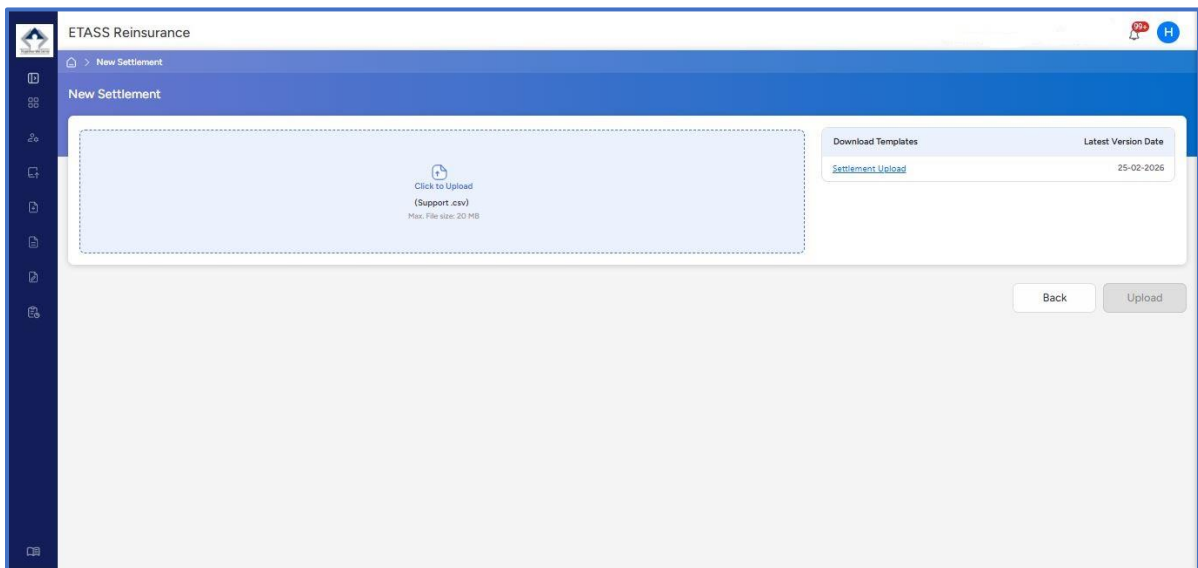
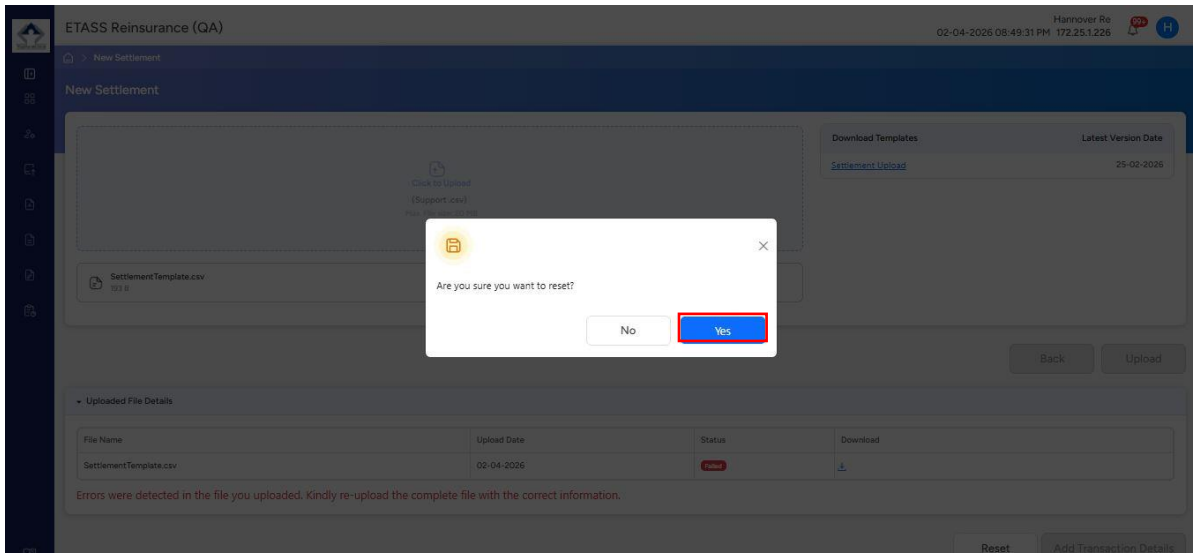
- On clicking the **Reset** button, a pop up message will be displayed with yes and no option.



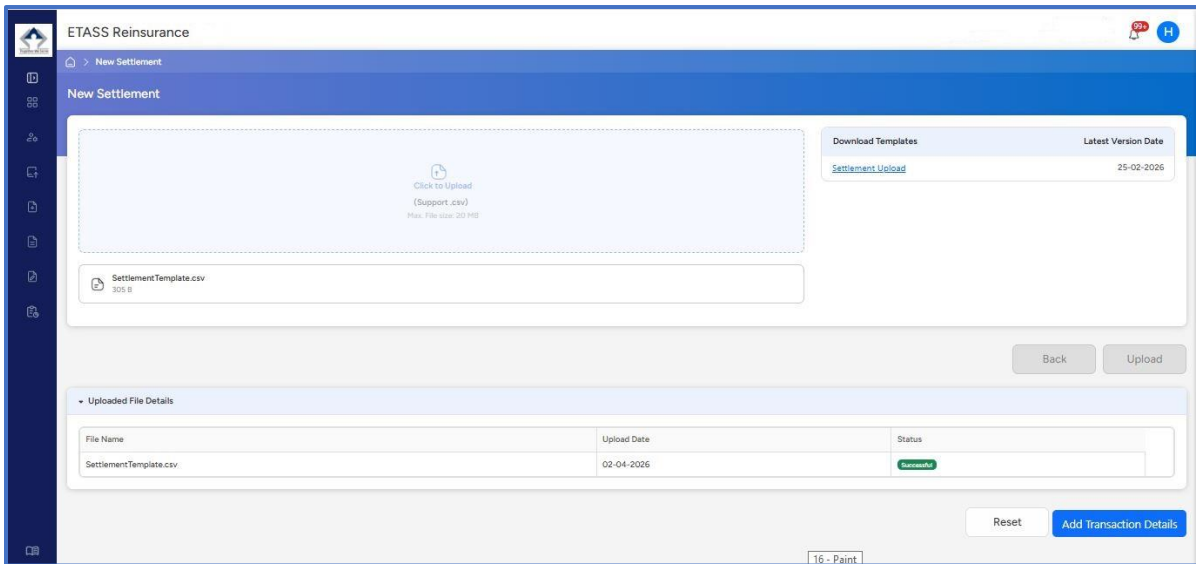
- On selecting '**No**' option, the user will remain on the same page.



- On click of '**Yes**' option, the user will be redirected to Upload new settlement page from where the user can re-upload the settlement on failure.

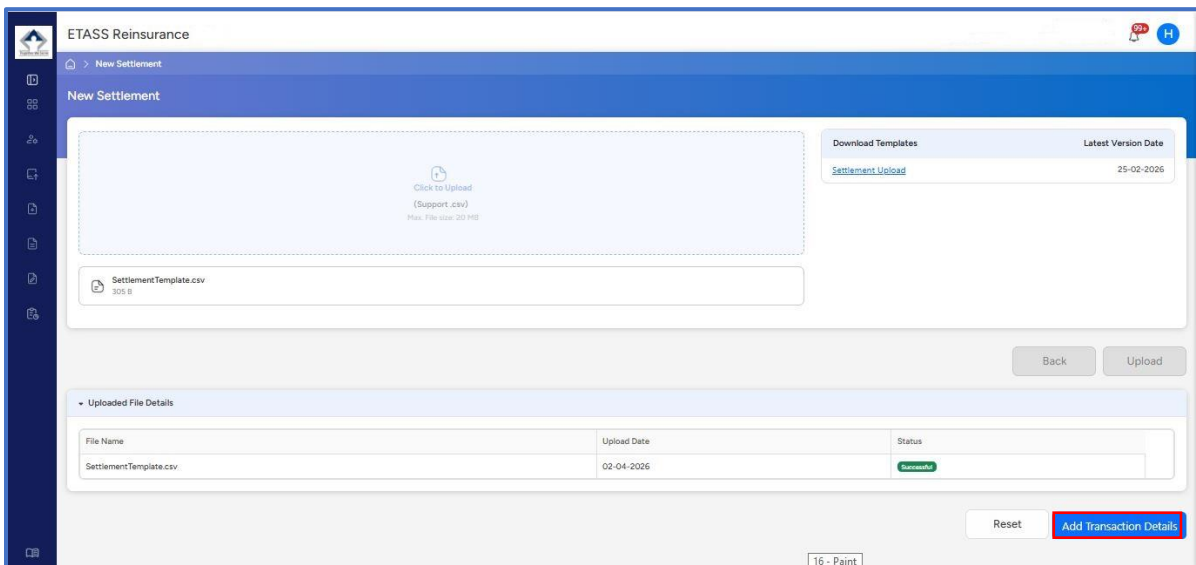


- After making the necessary correction in the file. User will re-upload the file.

Step 2: Add Transaction Details

- Click on Add Transaction Detail



- The **Transaction Details** section will be displayed, where the user needs to enter the settlement transaction details.
- Enter the **Transaction Number, Transaction Date, Transaction Currency, Transaction Amount, Settlement Amount (as per booking currency), and Remarks.**

Cancel Submit

- If the total amount of the selected AE and the total settlement amount in booking currency does not match, an error message will be displayed.
- The **Submit** button is enabled only when the total AE amount matches the total settlement amount.

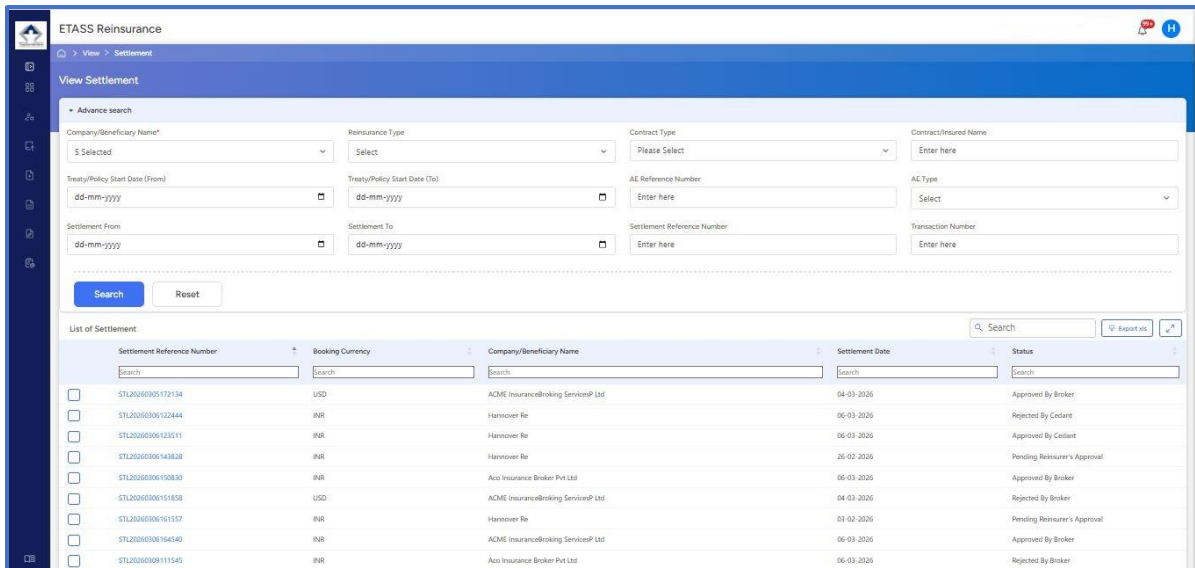
